





Q10 Are transfer pathways established between your institution and other institutions?



over next 3 years?



Q16 If enrollment growth is projected, is it expected to occur through existing or through the addition of new programs?






Q22 Are the following types of programs offered at your location? (choose all that apply)


Q28 How do you communicate your available services to both your current population and to your partners on the parent campus? (check all that apply)


Q29 How would you go about creating a separate billing system for students that would allow tuition and fees to flow directly to the branch? (check all that apply)


Q31 How would you go about working with parent campus administration and regents (if applicable) to determine campus appropriations?


Q32 How would you build out 3-year and 5year projections for academic programs, operations, and student services?

Q36 The funding model my Institution uses for off-campus locations can BEST be described as:





